## Major Infrastructure Maintenance Window – January 2015



IT systems, like our cars, need regular maintenance to ensure trouble-free operation and the University's complex IT infrastructure is no different. IT Services has a rolling schedule of agreed 'Major Infrastructure Maintenance Windows' for the coming two years, when planned work will normally be undertaken. The idea is to allow all organisational units, staff and students to plan for these dates in order to avoid arranging any activity, with a critical dependence on IT, during the 24-hour period. IT Services will use service resilience, where feasible, to mitigate any disruption to core services but cannot guarantee that there will not be disruption to any or all services. Staff at the Hospital offer excellent counselling and bereavement services for families, but they do not have a dedicated space where they can deliver what can be devastating information and news. The Hospital aims to raise £1 million to build a unique unit that will provide palliative and bereavement care in peaceful, caring surroundings. The prize draw will take place on 27 February 2015 at the BUAFTA awards ceremony and winners will be notified after the event. ## News...

### Support our researchers developing a new treatment for cancer patients

Research has led to the development of a potential new treatment for Epstein–Barr virus (EBV) cancers; a therapeutic vaccine to alert the immune system of patients with an EBV-related cancer to attack the cancer cells. The vaccine could help the 200,000 people diagnosed with an EBV-related cancer each year. The researchers hope to get additional scientific data from the trials by using the very latest cutting-edge techniques and are currently raising funds with Cancer Research UK to do this. They need to reach their £40,000 target by the 11 December 2014 – to find out more about the research and how to donate visit the [staff intranet](#).

## National award for Careers Network

The University's Careers Network with Careers in Business have won a [national award](#) in the category Prospects Postgraduate Best Careers Employability Team. This is the first year for this category so it is great to win this inaugural award. The judges were impressed with the well-thought-out approach, and the joined up and integrated model which was evident in the submission. They also made reference to the support provided across the pathway for students considering further study and pre-starting a postgraduate course, and also for students currently on course with programmes such as Talent Pool and in to employment.

This two-week course will help answer important questions around the issue of character, its importance and whether it can be taught. The MOOC will begin on 19 January 2015 and will be delivered through the FutureLearn platform. The course will tap into the increasing public and political interest in character and character education. ## Ethics in Syria: Analysing the International Response

Over the last three years, more than 100,000 Syrians have been killed and nearly half of the population have fled their homes. There are currently no credible prospects for peace in the near term and many analysts expect the war to continue for many years. Leading academics and human rights activists convene a panel to discuss the ethics of responding to the crisis in Syria. This event is presented by the Institute for Conflict, Cooperation and Security and the Centre for the Study of Global Ethics, and is chaired by Professor Heather Widdows, Department of Philosophy. ## Music and Alabaster

**Dates/times:** Monday 15 December, 9.00am–5.00pm

**Venue:** Evesham Room, Hornton Grange

Hosted by the Institute of Advanced Studies, this workshop brings together scholars, museum professionals and musicians to explore the interaction of the sounding and the visual in the English late Middle Ages, with a particular emphasis on polyphonic music and Midlands religious alabasters and their devotional contexts in the long 15th century (c.1380–1520). This workshop offers an important cultural parallel, which will function as a showcase for national and local patrimony as well as a potential boost in national and international profile for important, but neglected, regional collections. Discussions will take a different view: while precise archaeological and archival knowledge offers valuable signposts, these phenomena operated within a context of typology and exemplarity that allowed for a wide range of musical-visual juxtapositions within any given context. This typological frame, based on contemporary functionality, thus allows us to derive historical insights from the combination of its component elements. [Book online](#).
